Hail Damage Reporting

If you had hail damage from the Thursday May 22nd storm, report it to your local Farm Service Agency (FSA) office. The local office servicing Atlantic, Cape May and Cumberland Counties is located at 1318 South Main Rd., Building 5, Suite A, Vineland, NJ; telephone: 856-205-1225. They need to know acreage and crops damaged, and if there was building or equipment damage. Make sure to take pictures of the damage so if there is a disaster declaration this helps prove your damage.

Anyone who has crop insurance should have already reported the damage to their agents. Do not destroy the crop until they have the opportunity to assess the damage.

Low interest loans for food safety improvements

The Farm Service Agency (FSA) Farm Storage Facility Loan Program has been expanded to cover many upgrades that will help address changes a grower may need for food safety requirement compliance. The low-interest financing is to help producers build or upgrade farm storage and handling facilities. There is a long list of equipment that may fall under the loan program including: brush polishers, bulk bin tippers, case palletizers, conveyors, food safety related equipment (sanitizers, pre washing equipment, filter tanks, etc.), drying tunnels, dumpers, hoppers, hydrolifts, hydrocoolers, ice machines, quality graders, roller creep-feeders, roller spray units, sealants, sizers, shorting bins/tables, washers, waxers, weight graders. If you need to make changes for the Food Safety Modernization Act or for a third party audit this program may help. Contact the Atlantic/Cape May/Cumberland County FSA office for details.

USDA is Seeking Applications for Loans & Grants To Help Farmers, Ranchers and Small Businesses Cut Energy Costs

USDA Rural Development Acting State Director, Kenneth C. Drewes, is seeking applications from farmers, agricultural producers and rural small businesses to purchase renewable energy systems or make improvements for energy efficiency projects.

Developing renewable energy presents an enormous economic opportunity for rural America. This funding will help farmers, ranchers and rural small business owners incorporate renewable energy and energy efficiency technology into their operations, create jobs and help America become more energy independent. When small rural businesses and farmers cut their energy costs with cleaner and more efficient energy, we are both helping their bottom lines and reducing the amount of greenhouse gas pollution that affects our climate.

The funding is being provided through USDA's Rural Energy for America Program (REAP). Investments from programs like REAP help support the true engine of America's economic growth—a thriving middle class. REAP is one of many USDA programs and initiatives to support an expanded domestic energy economy. In addition to helping to increase renewable energy production, USDA makes investments in the bioeconomy, provides support for the emerging biobased products industry, supports new technologies and supports energy efficiency improvements.

Created by the 2008 Farm Bill, REAP was reauthorized by the recently passed 2014 Farm Bill. For fiscal year 2014, USDA plans to award up to \$12.3 million in grants and \$57.8 million in loan guarantees. Additional REAP funds provided by the Farm Bill will be made available with a subsequent notice.

Requests for grants may not exceed 25 percent of a project's cost—either for stand alone grant requests or for grants combined with loan guarantees.

EPA and DEP Inspections in New Jersey

In the last issue of Cultivating Cumberland we mentioned that the United States Environmental Protection Agency (EPA) would be conducting inspections in New Jersey for compliance with federal pesticide laws. Make sure your worker protection recorders are up-to-date and the worker protection bulletin board is complete. Refer to the April Cultivating Cumberland for a list of what needs to be on the board. If you need additional copies contact our office.

The Department of Environmental Protection (DEP) has been out checking pesticide records. There are three issues that have come up relating to the records:

1. When recording application time make sure it is listed as A.M. or P.M.
2. Use the full name (first and last) of the person making the application, and
3. The applicator number or handler number must be on the form. Do not use the applicator number when the handler is making the application.

USDA National Farmers Market Directory 2014 Update

USDA National Farmers Market Directory Team

The U.S. Department of Agriculture's Agricultural Marketing Service has launched its annual update process for the USDA National Farmers Market Directory. More than 2,600 markets have already updated their information in time for the 2014 market season.

The USDA National Farmers Market Directory is one of the most comprehensive and up-to-date sources of information about farmers markets. The Directory provides members of the public with convenient access to information about US farmers market locations, directions, operating times, product offerings and accepted forms of payment for more than 8,100 farmers markets across the country.

In 2013, USDA launched the Federal Application Programming Interface (API). The new Farmers Market Directory API gives developers and designers direct access to the wealth of farmers market information housed in our online database. With over 8,100 farmers market listings available for all 50 states, apps and websites that previously relied on a download or export of the data set can now access and interact with the data in real time. This means more accurate and up-to-date information for the foodies and farmers market lovers who use the apps.

Markets managers that have a valid email address listed in the 2013 Directory were sent a separate email invitation with a specific link to update their market listing. So make sure to check your spam filter too! Managers of markets that didn't list their market in the 2013 Directory or market managers that were listed in the 2013 Directory but could not be reached by email are now able to list their market through the general web portal where they can search for their market listing or complete a blank listing form.

Market listings can be added and updated by going to www.usdadirectoryupdate.com. Whether updating an existing listing or registering a new market, providing the required information should take less than 10 minutes. **Updated information and new market listings submitted from May 6th to June 23rd will be published in the Directory by July 7th.**

Please note: Even if you listed your market in previous years, please make sure to review your listing to make sure all of the information we have on record is still correct.

The USDA is conducting a short survey about farmers markets in the US to measure scope and growth of this sector, as well as issues and challenges it might be facing. The survey is totally voluntary and separate from the directory update. At the end of the directory update process market managers will be asked if they are willing and able to participate in the survey.

INVASIVE EMERALD ASH BORER DETECTED IN NEW JERSEY

NJ Department of Agriculture officials have confirmed that the emerald ash borer (EAB), an invasive beetle that attacks and kills ash trees, has been found in Somerset County.

A landscaper investigating unhealthy trees in a retail area in Bridgewater last week alerted the Department. Inspectors took samples and insect larvae were sent to the US Department of Agriculture's Systematic Entomology Laboratory where the specimens were confirmed.

For the past four years the NJDA and DEP have participated in an Emerald ash borer survey but none of the beetles were found in the more than 300 traps set up around the state. Emerald ash borer had already been detected in Pennsylvania and New York counties bordering New Jersey.

"We have been rigorously monitoring the EAB's movements and educating the public about what to look for in case the beetle entered our state," said NJ Secretary of Agriculture Douglas H. Fisher. "Now we will be informing homeowners about the actions they can take to protect their ash trees from this tree-killing insect."

EAB is now present in 23 U.S. states and two Canadian provinces. It was first discovered in Michigan in 2002 and has since killed tens of millions of trees.

"Since the emerald ash borer has been active just over our borders for quite a number of years, we expected that it would be found in New Jersey eventually," said State Forester Lynn E. Fleming. "The DEP will work with the Department of Agriculture and other appropriate agencies to educate landowners on how to identify this invasive beetle and mitigate infestations."

The adult emerald ash borer is a metallic green insect about one-half inch long and one-eighth inch wide making it hard to detect in the wild. The female beetles lay eggs on the bark of ash trees. The eggs hatch and the larvae bore into the bark to the fluid-conducting vessels underneath. The larvae feed and develop, cutting off the flow of nutrients and, eventually killing the tree. EAB attacks and kills North American species of true ash and tree death occurs three to five years following initial infestation. EAB is native to Asia.

The state will now survey trees in the area surrounding the initial find to determine the extent of the EAB infestation. It is expected that a federal quarantine will be expanded to include New Jersey.

Homeowners who own ash trees can take steps to protect their trees. Treatment products are available at local retail establishments and state-certified pesticide applicators can treat for EAB. Signs of EAB include: canopy dieback beginning at the top of the tree and progressing through the year until the tree is bare; sprouts growing from the roots and trunk; split bark with an S-shape gallery; D-shaped exit holes and more woodpecker activity, creating large holes as they extract the larvae.

To prevent spread of the beetle, do not move firewood. Firewood is a vehicle for movement of tree-killing forest pests including EAB and Asian longhorned beetle. Use locally-sourced firewood when burning it at home and when travelling, burn firewood where you buy it. Make sure to burn all wood purchased.

Worker Protection Standard Comment Period Extended

The United States Environmental Protection Agency is extending the comment period for the proposed revisions to the agricultural Worker Protection Standard for an additional 60 days, until August 18, 2014, in response to requests from growers, industry, farmworker advocates and states for additional time to provide input. The proposed changes were attached to the May issue of Cultivating Cumberland.

Reminder: It is very important for all stakeholders comment on these proposed revisions. This is the ONLY opportunity for stakeholders to have input before the WPS revisions are finalized. Comments on both the "preamble" and proposed changes are encouraged by the EPA.






