SADC Deer Fencing Funding

The NJ State Agriculture Development Committee (SADC) recently dedicated funding (\$500,000) for 50% cost-share grants to farmers for installing high tensile woven-wire fencing on permanently preserved farms. The cost share applies to fencing materials and installation. An applicant can apply for a cost-share of up to \$200/acre, with a total award amount capped at \$20,000. (As a ball-park estimate: accounting for the farmer's 50% contribution, the maximum level of funding would support fence installation around roughly 20+ acres.) The application deadline is March 23, 2017.

To be eligible for the program:

- an applicant must be an established farmer (see definition in the policy overview, per the link below);
- the land on which the deer fencing is to be constructed must be permanently preserved farmland enrolled in the Farmland Preservation Program or Transfer of Development Rights Program;
- an applicant must participate in a SADC-approved deer fence installation training session;
- an applicant must install deer fencing in accordance with the specifications outlined in the SADC policy (see policy at link, below).

Applications will be reviewed and prioritized, per the criteria outlined in the program policy (e.g., estimated deer density per square mile, crop type to be fenced, hunting status on the farm and adjacent properties, farmers' military status, etc.).

Those selected for funding will need to complete a training session on proper fence installation that will be offered in partnership with NJAES/RCE (likely in early to mid-summer).

I-9 Forms Update

Which form I-9 should be used?

Beginning January 22, 2017, employers must only use the revised version Form I-9, Employment Eligibility Verification, dated 11/14/2016, to verify the identity and work eligibility of every new employee hired after Nov. 6, 1986. Available at https://www.uscis.gov/i-9

Which form I-9 should I use for reverification?

• Reverification of expiring employment authorization for existing employees must be completed using the revised version, dated 11/14/2016.

On or after January 22, 2017, will prior versions of Form I-9 be valid for use?

Prior versions of the form will no longer be valid for use.

What should I do with the previously completed Form I-9?

 Employers should continue to follow existing storage and retention rules for all of their previously completed Form I-9. https://www.uscis.gov/i-9-central/retain-and-store-form-i-9

Are there penalties?

Employers who fail to use Form I-9 (dated 11/14/2016 N) on or after January 22, 2017 may be subject to all applicable penalties under section 274A of the Immigration and Nationality Act, 8 U.S.C. 1324a, as enforced by U.S. Immigration and Customs Enforcement (ICE).

Getting Pesticide Test Results:

- Go to: http://www.nj.gov/dep/
- On the left side of the screen, click the light blue link "pesticides"
- "Bureau of Licensing & Regulations" will come up. Click on "pesticide" under "About Us"
- This takes you to "Licensing & Pesticide Operations Links". In the middle of the page, under "Exams", click on the link that corresponds with your last name. This will take you to the DEP Dataminer page.
- You must enter the following information: Last Name, birth date and last 4 digits of your social security number.
- A screen will appear with your information and test results

To obtain the current status of your credits:

- Go to: http://www.ni.gov/dep/
- On the left side of the screen, click the light blue link "pesticides"
- "Bureau of Licensing & Regulations" will come up. Click on "pesticide" under "About Us"
- This takes you to "Licensing and Pesticide Operations Links". At the top of the page under "Online Payments and Reports", click the "online reports" link.
- This will take you to a list of reports that are available. Toward the bottom of the list there is a link "Private certified pesticide applicators specific information". At this link you must enter your birth date (a calendar will appear, ignore the calendar and put in the date: ie: 01-01-1901, last 4 digits of your social security number and your license number (which appears as a drop down menu and must be chosen from the list). This report will give you the up-to-date information on credits obtained and license status.

To be eligible to take the Core exam, the applicant shall submit proof of completion of a Department approved Basic Pesticide Applicator Training Course. The course shall provide a working knowledge of the following: proper use of application equipment, potential hazards involved in applying pesticides, instructions for the mixing of pesticides, protective clothing and equipment, applicable State and Federal pesticide laws and regulations, interpretation of pesticide labels and understanding integrated pest management. Proof of course completion must be submitted with the Core Certification Exam application form in order to take the test for a commercial pesticide applicators license. Pesticide applicators currently holding a license may attend to obtain recertification credits.

After receiving your license, a Commercial applicator must accumulate 8 units (one unit equals 30 minutes of instruction time) of Core subject matter credit and 16 units of Category subject matter credit (for **each** Category of certification) over the 5 years.
