#### Training for the Food Safety Modernization Act and an Audit What is the Difference?

We continue to receive questions about what is the difference between the Food Safety Modernization Act (FSMA) training and trainings for third party audits.

The shortest answer is the FSMA training is required by the Food and Drug Administration (FDA) as part of complying with FSMA where one-person per farm operation must receive training. There is no follow up training required for FSMA. Third party audit training is to help growers develop their written food safety plan for an audit required by a buyer. It is not government regulation.

We have developed a two-day training where growers can get both the FSMA and third-party audit training. This reduces the need to attend two sessions at different times. The six or seven-hour FSMA or PSA training covers all aspects of food safety as it relates to FSMA for growers. The seven modules were developed by the Produce Safety Alliance (PSA) made up of research and extension personnel at land grant institutions across the United States along with private industry and growers. This is the only training approved by FDA. Over 5,500 growers have been trained across the United States since September 2016 which includes 265 in New Jersey.

Along with the PSA training is the opportunity for each farm operation to have a walk through from the trainers and the New Jersey Department of Agriculture (NJDA) to help them assess their operation for compliance to FSMA. The On Farm Readiness Review (OFRR) is completely voluntary and confidential. The FDA through the NJDA is providing grant funds for the Rutgers Food Safety Team to carry out these assessments. We will be offering this service starting in spring 2018. The compliance date for the largest operations (\$500,000) is starting January, 2018, but the FDA has delayed formal inspections until 2019 to give growers the opportunity to go though an OFRR and make modifications to their operations.

Growers who have third party audits still need to comply with FSMA and may be inspected starting in 2019. The initial group will be operations having produce sales over \$500,000 over a three-year average. Followed by operations with sales between \$250,000 - \$500,000 and \$25,000 - 250,000. Compliance dates for the last two groups are 2019 and 2020. We do not know if inspection dates for these last two groups will be extended.

Attached to this newsletter is a list of the trainings offered during the winter 2017-2018 across the state. This is your opportunity to learn more about FSMA, take the one-time training and if needed attend the second day for plan writing for a third-party audit.

#### Brucellosis Confirmed in Raw Milk

For the 2nd time in 3 months, CDC is warning people who might have consumed contaminated raw milk and milk products to visit their doctor. People who bought and drank raw milk from a company called Udder Milk may have been infected with a rare but potentially serious bacterium called \_Brucella abortus\_ RB51. While brucellosis can cause anyone to become sick, women may suffer miscarriage and other pregnancy complications, making it critical for pregnant women who may have consumed the raw milk from Udder Milk to seek medical care immediately.

In late September 2017, a New Jersey woman became ill after drinking raw milk from the company. CDC confirmed that her illness was \_Brucella\_ RB51 in late October 2017. Because Udder Milk has not provided information about the farms that supply their milk, it has not been possible to trace the source of the woman's infection. CDC scientists have been collaborating with state health officials on the investigation. The Department of Agriculture and the Food and Drug Administration are working with state health and agriculture officials to trace the source of the contaminated raw milk and raw milk products.

Until more information is available about which farms may be supplying contaminated milk or until officials can test milk from the farms, CDC recommends that anyone who drank raw milk or consumed raw milk products from Udder Milk in the past 6 months visit their doctor for antimicrobials to prevent illness. Information suggests that the company delivers milk in Connecticut, New Jersey, New York and Rhode Island.

The New Jersey patient is the 2d known domestically acquired illness caused by \_Brucella\_ RB51 in raw milk in the USA in 2017; the other was in Texas in July 2017. The Texas and New Jersey incidents are not connected.

The locations of the farms supplying Udder Milk are not known. Neither are the places where the company sells and distributes raw milk and other products. Online information about Udder Milk points to membersonly websites through which people purchase raw milk online and delivery sites that shift to avoid detection by public health officials. Selling and distributing raw milk and raw dairy products is illegal in New Jersey, and selling it outside of the farm that produces it is illegal in New York. Farms that sell raw milk in New York also must have a permit to sell it.

All people who consumed raw milk and raw milk products from Udder Milk should seek medical care and start treatment to prevent future chronic disease from RB51. The RB51 strain is resistant to some antimicrobials that would normally be used to prevent or treat brucellosis.

Therefore, people who consumed raw milk from Udder Milk should tell their doctor that they may have been exposed to this particular strain. Doctors can learn more about testing patients for RB51 and which antibiotics to employ to prevent or cure infection at <<u>https://www.cdc.gov/brucellosis/clinicians/rb51-raw-milk.html</u>>.

People who have consumed the milk and other products made from Udder Milk raw milk should check themselves daily for fever for one month after they last drank the milk and watch for other brucellosis symptoms for 6 months. These symptoms include muscle pain, lasting fatigue, arthritis, depression, and swelling of the testicles.

Untreated \_B. abortus\_ RB51 infection can result in long-term health problems like arthritis; heart problems; enlargement of the spleen or liver; and, in rare cases, nervous system problems like meningitis. RB51 can cause severe illness in people with weakened immune systems and miscarriages in pregnant women.

## Local FFA student Wins Proficiency Award

#### New Jersey Department of Agriculture

Cumberland County's Joshua Loew was named the winner of the National FFA Proficiency Award in Outdoor Recreation—Entrepreneurship/Placement at the 90th Annual National FFA Convention and Expo in Indianapolis, Ind.

Joshua is a member of the Cumberland Regional High School FFA and a Newport resident. He was one of four finalists for the award. Joshua became eligible for the national award after winnering the New Jersey state FFA competition earlier this year and was the first New Jersey member to be a finalist since 2006. He received a \$500 scholarship for winning the national honor.

The nomination for Joshua came in large part because of him employment at Beaver Dam Boat Rentals on Oranoken Creek. While being an on-the-water guide where he pulled as many as six boats at a time through an intricate waterway system, he also learned to identify multiple species of wildlife and plant and tree life. His regular interaction with customers broadened his conversational skills during his five years at the job, where he is comfortable discussing a wide range of topics.

The proficiency awards recognize outstanding student achievement in agribusiness gained through establishment of a new business, working for an existing company or otherwise gaining hands-on career experience. In New Jersey, more than 2,500 FFA members in 37 chapters engage in personal, career and leadership development activities that challenge them to excel as they develop agricultural skills and competencies for the future.

Joshua believes the experience helped him develop leadership, teamwork, customer service and critical thinking skills. He hopes to become a biological scientist in the future, studying animal species and ecosystems.

Other national winners from New Jersey came in the Agriscience Agriscience Fair Division. Darrel D'Souza and Jonathan Shen, members of the Biotechnology FFA Chapter in Monmouth County, won Division 6 in the Environmental Services/Natural Resource Systems category. A top individual from New Jersey was Kass Wojcik of Newton FFA, who was 10th overall in Environmental and Natural Resources Career Development. Several other NJ FFA members and chapters received Gold, Silver and Bronze awards in various categories.

The program allows producers to obtain protection for their crops against natural disasters that result in lower yields or crop losses, or prevents crop planting.

Remaining Deadlines for 2018 NAP Coverage:

- 12/31/17 Asparagus, Beets, Broccoli, Cabbage, Carrots, Cauliflower, Greens, Herbs, Horseradish, Kohlrabi, Leeks, Lettuce, Parsnip, Peas, Potatoes, Radishes, Rhubarb & Turnips
- Beans, Brussel Sprouts, Cantaloupe, Celery, Corn, Cucumbers, Eggplant, Hon eydew, Oats, Okra, Peppers, Pumpkins, Sorghum, Sorghum Forage, Soy beans, Squash, Sunflower, Sweet Potatoes, Tomatillos, Tomatoes, Watermelon & Yams



Introduction to Produce Safety

Worker Health, Hygiene, and Training;

Soil Amendments

Wildlife, Domesticated Animals, and Land Use

Agricultural Water (Part I: Production Water; Part II: Postharvest Water)

Postharvest Handling and Sanitation

How to Develop a Farm Food Safety Plan

In addition to learning about produce safety best practices, parts of the FSMA Produce Safety Rule requirements are outlined within each module. There will be time for questions and discussion.

### **Benefits of Attending the Course**

Individuals who participate in this course are expected to gain a basic understanding of:

- Microorganisms relevant to produce safety and where they may be found on the farm
- How to identify microbial risks, practices that reduce risks, and how to begin implementing produce safety practice on the farm
